Chesterfield County Commissioner of Revenue

Duties - The Commissioner of the Revenue is the chief tax authority for the county. Duties include assessing all taxable personal and business property, administering tax relief programs, and processing state income tax returns.

They are accountable directly to citizens for fairly and equitably applying state and local tax laws. In Chesterfield County, the Commissioner of the Revenue assesses \$200 million per year in personal property, business and other taxes. The office also issues business licenses, administers real estate tax relief and processes state income tax forms.

Q: What is the greatest challenge facing the office and how will you address it?

A: When I took office in November 2017, it was clear that radical change was needed to modernize our service. My newly formed leadership team laid out a number of strategic initiatives to enhance customer experience and make our service more efficient. The biggest challenge now is the need for partnership from other County departments to continue forward progress. I endeavor to highlight the value of the changes made and look forward to the outcome of the November elections to drive change.
Q: What will be your priorities during your term?

A: The changes I've brought to the Commissioner's office have already made a significant difference. Productivity is up and customer service has improved. Once re-elected, I will continue implementing the changes I initiated in my first term, with a focus on leveraging the County's \$4 million investment in our new tax management system into serving taxpayers online and building better decisioning and reporting tools to drive equitable distribution of the taxes needed to pay for public services.

Q: What is the most important responsibility of the Commissioner of the Revenue?

A: The primary responsibility of the commissioner of the revenue is the proper assessment of property values and taxes of various types. Data security comes along with that role as a primary responsibility of all state and local tax or revenue officers. I take both as fundamental to effective stewardship of the public trust.

Q: What is the greatest challenge facing the office and how will you address it?

A: The greatest challenge now is to restore faith in accountability that was lost when the current commissioner, Jenefer Hughes, disclosed Social Security numbers in a data breach last fall and offered multiple excuses while refusing a procedural audit to review it. I will immediately request an audit to review the incident and all office procedures. I have a 20-year track record of safeguarding your confidential data, and I will reinstate effective measures to make sure it is secure. **Q:** *What will be your priorities during your term?*

A: After ensuring that business processes and internal controls are effective and strong, I would capitalize on the efficiencies of the tax management system, which I lead in development, to improve customer service and save tax dollars. I would complete the development of the web portal which was part of the original project, to allow online filing. I would always strive to eliminate wasteful spending. And being accessible to taxpayers is an ongoing priority.

Q: What is the greatest challenge facing the Commonwealth's Attorney's office and how will you address it?

A: This job is about justice and safety through enforcing our laws. It's not about popularity. As your Commonwealth's Attorney, I will lead an office that will follow the "Rule of Law" and ensure the safety of our families. I will advocate for victims while ensuring attention to detail for every case – whether a felony or misdemeanor. My priority will be to seek justice for all citizens, even if its not always popular in the court of public opinion. Chesterfield deserves and expects nothing less.

Q: What is your position on the use of diversion, alternative sentencing, and restorative justice? **A:** Every case must be evaluated independently based on its own facts and circumstances. Q: What will be your priorities during your term?

Protecting the safety of Chesterfield families by prosecuting domestic violence and child abuse as aggressively as possible. Partnering with surrounding jurisdictions to develop a task force on human trafficking. Strengthening our response to criminal gang activity to reduce drug distribution and violent crime. Raising awareness in the community of the signs of abuse and addiction to prevent crime.

Q: What is the greatest challenge facing the Commonwealth's Attorney's office and how will you address it?

A: Combating decades of indoctrination with the false choice of "tough" or "soft" on crime. I am demonstrating that making our criminal justice system fairer and enhancing public safety are complementary efforts through policies that mitigate discrimination against lower income people in our community and implicit bias in policing, prosecution, and jurisprudence, through the establishment of a felony drug diversion program, and through constricting the "school-to-prison pipeline."

Q: What is your position on the use of diversion, alternative sentencing, and restorative justice? **A**: I support all three approaches, when thoughtfully pursued. I am establishing a felony drug diversion program, and maximizing the use of alternative sentencing programs. Restorative justice programming is most obviously applicable in our school system and in our court services unit, where diversion of juvenile delinquency cases is frequent. I've been educating myself on the model, with an eye toward broader possibilities within our justice system.

Q: What will be your priorities during your term?

A: The continued assertive and skillful prosecution of violent crime, including but not limited to crimes of domestic violence. The maturation of our felony drug diversion program (currently in a pilot project stage). The continued reduction of the use of cash bail. The establishment of a mental health docket in our courthouses. Increased diversity in our office. Legislative engagement to advocate for laws enabling additional justice reform. Raising the asset forfeiture threshold. Discovery reform.

Duties - The five-member Chesterfield Board of Supervisors is the policy making body of the county. It passes ordinances and approves the annual budget. Members are elected from the five magisterial districts and they choose a chair and vice chair each year. Q: What are your priorities for managing residential and commercial growth in the county? **A:** Community vision is of paramount importance. A major example of this has been the decision to make mega-million dollar cuts in cash proffers for wealthy developers while expecting middle class homeowners pay the bill. Q: Do you support funding for improvements in bicycle and pedestrian infrastructure in Chesterfield County? Please explain why or why not.

A: I absolutely support the need for making chesterfield more accessible to bicyclists and pedestrians. A: Having diverse options in housing is extremely important. We must see how communities in different areas of the county wish to grow. Implementing a cash proffer policy on development that would better account for the financial costs associated with growth in the county is a must. Questions:

Q: What is the most important issue facing schools in the county and what will you do to address it? **A**: Teacher's pay must be addressed. CCPS must be on the forefront of teachers pay. Increasing teacher's pay leads to maintaining and recruiting the best quality teachers to our area, which leads to quality schools for CCPS. Strong teachers are the backbone to quality education. I will be a voice for increasing teachers pay at the School Board level and work with state and local representatives to make it happen. **Q**: How can schools best give students the research tools necessary to understand issues and verify their sources?

A: Students need the best tools in order to achieve their full potential. Funding should be allocated, so libraries are filled with up-to-date information and students are given access to online libraries and databases. Students must also be taught to use the research tools provided to them. Tools can only be used for effective learning if students/teachers know how to use the system to its full capability. We must also make sure that students have the technology available to use these tools.

Q: What education services do you support for students who are at risk of failing?

A: I support small and individualized attention programs. My daughter has an IEP (individualized education plan) for reading and writing and I have seen the improvements that come from it. 1 on 1 teaching is crucial for helping struggling students succeed. In my child's middle school, they have implemented a SOAR class where students can receive remediation and have additional time to complete classwork. These are great programs that help students who struggle, get back on their feet. **Q**: *Would you support a high school curriculum that focuses on the civic responsibility of voting*? **A**: Voting is crucial to our way of life. Americans have the responsibility to vote and allow our voices to be heard. While discussions on voting should remain non-partisan, the benefits, history of voting (both

good and bad), and the importance of voting should be taught in our schools. New generations must make their voices heard.

Q: What are the best methods of evaluating and supporting teachers?

A: To evaluate teachers we must measure the overall growth of a student academically, emotionally and socially. We need multiple ways to measure a student's overall performance. High-stakes testing is not the best way to evaluate a student or teachers success in the classroom. Teachers need to do more of what teachers do best: teach and mentor. We need less red tape for teachers to do their job effectively.

Q: What is the most important issue facing schools in the county and what will you do to address it?
A: Chesterfield is facing real issues surrounding equity, building maintenance and repair, and transportation. These issues stem from a longstanding pattern of under budgeting and subsequent under funding of our school division. As a school board member, I will advocate for and support the creation of a truly needs-based budget that allows for flexibility and accountability, but also reflects the actual needs of the division in order to meet the needs of our diverse community of learners.
Q: How can schools best give students the research tools necessary to understand issues and verify their sources?

A: For millennia, libraries have been the number one resource for accurate, reliable research based on primary sources. We can start by recognizing the value of our school libraries, and supporting the needs of our school library and media specialists. Through curricula that is developed by specialists, we can encourage students to be independent researchers and truth-seekers.

Q: What education services do you support for students who are at risk of failing?

A: After we have met the one counselor to every 250 student support ratio, we will be better positioned to identify students who are struggling and deploy intervention strategies. Our division must consider increasing teacher, specialist and aide staffing in order to meet the needs of our struggling learners. In some situations, academic failure is symptomatic of a larger social or emotional concern. That's why I also support increased resources for social-emotional learning (SEL) curricula.

Q: Would you support a high school curriculum that focuses on the civic responsibility of voting? **A:** Absolutely. I registered to vote eight months before I turned 18, anticipating my first chance to cast a ballot. I would not only support a high school curriculum, I would encourage engaging our youngest students in the discussion. It is important to discuss our country's history of disenfranchisement, and I believe that the more we teach our children that for many Americans, voting is right that men and women fought and died for, the more likely they will be to exercise their voice.

Q: What are the best methods of evaluating and supporting teachers?

A: I believe teacher performance is best measured by student growth. Teacher evaluations should not be tied to high-stakes tests, developed by for-profit companies and written with implicit biases. Growth measurements ensure that every student is learning, high-stakes tests do not accurately reflect what a student has learned and understands. The best way to support our teachers in Chesterfield is to pay them a salary that is commensurate with their experience and education.

Q: What is the most important issue facing schools in the county and what will you do to address it? **A**: School safety is the most important issue facing schools today. Q: What is the most important issue facing schools in the county and what will you do to address it? **A:** Building maintenance is a critical issue facing our county. Decades of deferred maintenance has put us 88 million behind in repairs. With decreasing Federal funding, having this amount of deferred maintenance makes us vulnerable. I will lobby for more money in our budget for building maintenance and prioritize repairs using the facility condition report. I will work hard to build the political will to invest more in our schools, an educated population builds a stronger democracy.

Q: How can schools best give students the research tools necessary to understand issues and verify their sources?

A: When I was in school, we had sessions in the library that taught us how to use the library for research. We need to do the same thing with the internet. Teaching kids critical thinking skills will allow them to look at a number of different things; information on the author, the purpose of the article, is the article objective, is the information accurate, the reliability of the website that hosts the article. This approach will help them determine whether or not they should use that source.

Q: What education services do you support for students who are at risk of failing?

A: We must first determine why the child is at risk of failing. Is the student hungry? Does the student have a learning disability? Is trauma impacting their ability to function? Each situation requires a different answer. One-on-one time with a teacher/support specialist is often critical to student success. This requires smaller classroom sizes. Additional counselors and behavioral support therapists for schools can provide one on one time tailored to what that child needs.

Q: Would you support a high school curriculum that focuses on the civic responsibility of voting? **A:** Fighting apathy fuels my passion. I have talked many people into door-knocking or donating for their first time. If I, as a mom of four, can figure out how to run a family and a campaign and serve in office, I can model to other ordinary folks that they can get involved. I have had students involved in my campaign. I recently found out that one of my supporters had never registered to vote. After I sent them the link, they responded that they are now registered. Yes, I support this curriculum! **Q:** What are the best methods of evaluating and supporting teachers?

A: The effectiveness of each teacher can vary by school, type of programs (Center Based Gifted, Special Education, etc.), subject, the teacher's experience level, as well as the expectation of the administration. Evaluations should include a variety of measures and be based upon goals mutually set by the teacher with an administration that focuses on the needs of students and the aspirations of the teacher and that values student growth over test performance.
