Goochland County Commissioner of Revenue

Duties - The Commissioner of the Revenue is the chief tax authority for the county. Duties include assessing all taxable personal and business property, administering tax relief programs, and processing state income tax returns.

Duties - The Goochland Board of Supervisors has five members elected from the electoral districts in which they live. It enacts ordinances, approves funds, sets tax rates, and establishes policies for the administration of the County's public services. It also appoints a County Administrator, who directs the county's day-to-day operations. Members choose a chair and vice-chair each year.

Questions:

Q: What are your priorities for managing residential and commercial growth in the county?

I support using the comprehensive plan to request that builders factor in workforce housing when planning new developments.

A: I love our county and I believe that we can do better. If elected I will prioritize: Universal Broadband Access for all unserved areas of the county. Equal Fire and Rescue response times and results for all districts. Support and expand our excellent public schools. We need to protect our farmland and the county's rural nature. Questions:

Q: What are your priorities for managing residential and commercial growth in the county?

A: My preference for managing residential and business growth in Goochland is to use the Comprehensive Plan, which was developed by county leadership and engaged citizens. Q: What are your priorities for managing residential and commercial growth in the county?

A: Managing the growth that is coming is critical not just for our economic success but the desire I hear every day to maintain the rural nature of our county. Q: What investments or policy initiative would you support to meet housing needs in your county? **A:** I have been invited by Goochland Cares, a great non-profit partner who has deep roots in our community, to work on a regional team designed to address some of the housing needs in our county. We believe there is a more significant issue of homelessness and sub-standard housing that we need to address. The first step to building a plan to solve the problem is to assess the problem and this is the first focus of this exciting partnership.

Q: What do you think are the most important issues for the county and what will you do to address them?

A: While broadband, rural vs. development, schools, and public safety are common and correct political buzz words I believe the most important issue in working towards improving all of them is citizenship. Q: What are your priorities for managing residential and commercial growth in the county?

Q: What are the chief transportation needs in your county, and how will you address these needs? **A:** Growth drives traffic congestion. This is why managing growth is so critical to a healthy lifestyle.

Questions:

Q: What is the most important issue facing schools in the county and what will you do to address it? **A:** Currently Goochland County Schools is facing a shortage of minority teachers. Limited affordable housing in Goochland discourages young teachers from coming to Goochland. I would enjoin the real estate community to help assuage this problem. I would encourage Goochland graduates to become educators and return to Goochland to teach, perhaps by means of scholarship(s) via private organizations.

Q: How can schools best give students the research tools necessary to understand issues and verify their sources?

A: Instruction should include teaching students the difference between fact and fiction and how to verify their facts. Included should be exercises in researching popular news stories; access to hi-speed internet to analyze them and report to the class, who, in turn get to analyze the presentations submitted. Class goal is separating truth from fiction. Teach them to recognize the earmarks of truth and those of fiction.

Q: What education services do you support for students who are at risk of failing?

A: Encourage early identification of the students that are struggling. Bring in parental support, interfacing parental, teacher, student and school system. Give students every opportunity to enhance their perspective of self-worth. Most students that are dropping behind are the same students with poor self concept; that have problems at home, contribute to bullying, either as being a bully or bullying others. Students that fall behind need to be identified quickly for remediation.

Q: Would you support a high school curriculum that focuses on the civic responsibility of voting? **A:** I would definitely support a high school curriculum to teach students how to evaluate candidate platforms and recognize diversity, but appreciate differing views; just as important is listening to each other before making decisions. Give students more hands on experience in the voting process (ie mock

elections); mock campaigns; debates; and forums for the Student Government. Involve students in current election processes at all levels, federal, state, and local.

Q: What are the best methods of evaluating and supporting teachers?

A: Students have a more rounded education when teachers teach a curriculum, not teach to satisfy state testing standards. When a child is equipped with a well-rounded education, testing should not be problem, testing should be a necessary event not the controlling factor to education. Address salary discrepancies, maintain salaries that compete or exceed surrounding districts. Listen to what teachers have to say.

Duties - Soil and Water Conservation Districts (SWCD) are subdivisions of state government responsible under state law for resource conservation. Activities include outreach, education, technical assistance, and conservation planning. The Monacan SWCD serves Goochland and Powhatan counties. The District is Governed by a Board of Directors of local citizens who serve without pay. Two directors are elected from each county. The Virginia Soil and Water Board appoints two additional directors. District staff provide technical assistance in cooperation with other government agencies.

Q: What is the most important role of the Soil and Water Conservation District?

A: After eight years of service as a Director, I recognize the core function of the Monacan SWCD is to work with agricultural producers to implement voluntary Best Management Practices (BMPs). We do this by administering programs that allow producers to improve their operations, and advance clean water and soil conservation efforts. As a Director, I also personally work to keep a solid working relationship with Goochland County's administration, staff, and its Board of Supervisors.

Q: What is the greatest challenge facing the District and how will you address it?

A: Monacan SWCD's greatest challenge is expanding the number of agricultural producers participating in the voluntary BMP programs offered by the district. There are fewer family farmers in the Monacan District than there were 10 years ago. With a shrinking client base, the Monacan staff (1 full-time and 2 part-time employees), and the six volunteer Directors need to have higher visibility, and a focused outreach effort. We can do that by leveraging web technology and data-base marketing.

Q: What will be your priorities in the next four years?

A: 1. Creating an agriculture database of farmers in the Monacan District; 2. Launching a District website with on-line BMP enrollment opportunities; 3. Have a continued presence at Goochland Board of Supervisors' meetings; 4. Promote landowner enrollment in Goochland's land-use tax program; 5. Advocate for homeowner well water testing via Virginia's Cooperative Extension program; 6. Work with Goochland County's staff to meet the county's Watershed Implementation Plan III 2024 benchmarks

Q: What is the most important role of the Soil and Water Conservation District?

A: "To provide for the conservation of soil and water resources, control and prevention of soil erosion, flood water and sediment damages thereby preserving the natural resources of the Commonwealth." Duties of the Board, Soil & Water Conservation District, Code of Virginia.

Q: What is the greatest challenge facing the District and how will you address it?

A: Goochland, with its 20,000 inhabitants appears a small rural county, yet a thousand new homes are coming to the Centerville area alone. This will affect the county's water needs: It will put new demands on the aquifer at the same time as built up areas will block water penetration and increase run-off. We need to encourage developers and home owners to include retention ponds, rain gardens, etc. to slow the run off and allow the water to infiltrate back into the earth.

Q: What will be your priorities in the next four years?

A: In addition to the above: There are data sharing needs that need to be brought up to the legislature as the Dept of Agriculture has information the Soil & Water Conservation District (SWCD) could use. People who farm as a second activity need to be included on the farmers' roll so that they can participate in SWCD programs. Develop a tree planting program. Raise the profile of our SWCD, which in spite of years of good and productive services, remains somewhat of a mystery to the community.
