**Q:** What are your priorities for managing residential and commercial growth in the county? **A:** I will advocate for a Smart Growth strategy for the Varina District, one that preserves its beauty, green space and options for rural living and farming. **A:** I will advocate and support quality affordable housing projects and initiatives for families at all income levels in the Varina District that provide safe access to public transportation services. I will also advocate for expanding public bus transportation services, both in terms of access locations and hours of service.

**Q:** What do you think are the most important issues for the county and what will you do to address them?

**A:** With the prospect of a downturn in the US economy more likely than not over the next several years, important issues for the Varina District and the county include infrastructure, job, food and housing insecurity. **Q:** What are your priorities for managing residential and commercial growth in the county?

**Q**: What are your priorities for managing residential and commercial growth in the county?

**A:** Libbie Mill is a terrific example creating beautiful living communities w/ residential, commercial & recreation all seamlessly intertwined. To promote solid commercial growth, I approved an increase in the BPOL (Business & Professional Lic.) exemption to \$400k whereby 14k businesses now benefit, thus

making Henrico a terrific place to build a business. Business growth creates jobs and benefits our residents by keeping our tax rate low & our services high - a formula I work every day to maintain. **Q:** What, if anything, should be done to improve infrastructure for pedestrian safety along bus routes in Henrico?

A: Safety for our residents is always a top priority. I approved the continuation of \$2.5 million in sidewalks, multi-use paths & pedestrian crossings & together with my colleagues on the Board, worked to ensure funding for 20 miles of sidewalks and/or multi-use paths over the next 3 years. I am a dependable ear & even stronger voice for safety initiatives and will always be a tireless advocate for residents who choose to bike, run, or walk as they enjoy the outdoors in our beautiful county.

Q: In a recent public opinion poll, 82% of Virginia voters believe that people should be able to afford to live in the community where they work. What programs or policies would you support to promote workforce housing in your district?

**A:** I worked directly to hold firm on Henrico's low real estate tax rate, the first step in maintaining land value to our residents. I approved a budget that increased services for residents, while maintaining one of the lowest real estate tax rates in the region. To assist with affordability, I supported the REAP program (Real Estate Tax Advantage Program) & approved \$300k in additional funding to support an increase in the maximum income to qualify to \$75k & the maximum net worth up to \$400k.

**Q:** What do you think are the most important issues for the county and what will you do to address them?

A: We must provide a quality & well funded education for our children. I approved plans for 2 new high schools, a new elementary school & the largest increase in education funding in 13 years. I approved a 3% pay raise for teachers & allocated \$3.8m to address salary compression for veteran teachers. I funded additional positions to reduce class sizes & allow for more teacher planning time & funded plans that will reduce Brookland's use of mobile trailers by 68% and I'm not stopping there!

**Q**: What are your priorities for managing residential and commercial growth in the county?

**A:** We need representatives at the local level that really understand the needs of our community. A proposed housing development may create a need for more roads, or a school, or a grocery store. When I'm on the board I will work tirelessly WITH developers to make sure those needs are met before I give my support. Through this relationship I will ensure they include sidewalks, a mix of housing, retail and office space, and more compact development adjacent to transit stops in these areas.

**Q:** What, if anything, should be done to improve infrastructure for pedestrian safety along bus routes in Henrico?

**A:** I have witnessed and personally experienced the difficulties with safe access to public transportation. As Supervisor I will work to increase county investment in sidewalks and bike lanes. I will also work to have covered bus stops with benches installed, as the current practice of having a poll in the middle of the grass is unacceptable. The current infrastructure makes it difficult for people to utilize public transit and that needs to be corrected.

**Q:** In a recent public opinion poll, 82% of Virginia voters believe that people should be able to afford to live in the community where they work. What programs or policies would you support to promote workforce housing in your district?

**A:** This is a very personal question for me. As a small business owner who has a majority of my employees working in one end of the county but forced to live elsewhere due to housing costs, I see the impact on the community every day. As Supervisor I will work to promote the re-purposing of vacant land and underutilized space. I would also be open to examining current zoning practices throughout the county.

**Q:** What do you think are the most important issues for the county and what will you do to address them?

**A:** Education is one of the most important issues. I have pledged to raise teacher pay by 20% before the end of my first term. Having worked in corporate settings I know finding waste in the budget that can be redirected to address this issue will not be a problem. Districting and zoning policies also have an immediate impact on what schooling options are available. We need universal pre-k; this shouldn't be a function of which neighborhood a kid's parents live in. And as I said above, smart growth.

**Q**: What are your priorities for managing residential and commercial growth in the county?

**A:** Growth & development are a partnership among property owners, businesses & land developers; the supervisor's job is to coordinate. In Tuckahoe, most land is already developed, infill & re-development are the issues. Henrico uses the Enterprise Zone designation, an area identified for incentives to stimulate business development and job growth. We also have the UMU zoning classification which allows greater density with a mix of business and residential zoning.

**Q:** What, if anything, should be done to improve infrastructure for pedestrian safety along bus routes in Henrico?

**A:** The concept of Complete Streets facilitates safe access for pedestrians, bicyclists, motorists & transit riders of all ages & abilities. They make it easier to walk to retail areas & travel to work. I will continue to build on the countywide progress we've already made for sidewalk construction. Miles of sidewalks are added each year with annually earmarked money, at no additional cost to taxpayers. In Tuckahoe, I have added more than 5,000 feet of sidewalks in past the 4 years.

**Q:** In a recent public opinion poll, 82% of Virginia voters believe that people should be able to afford to live in the community where they work. What programs or policies would you support to promote workforce housing in your district?

**A:** The Board established the HHAC to help address this. They will advise the Board on housing issues, strategies, goals, & policies that will improve our housing stock, affordability & neighborhoods. Each member of the committee has experience: homebuilders, developers, lenders, realtors, non-profit and private sector professionals. We are assisting the Maggie Walker Community Land Trust with their work on making housing more affordable.

**Q:** What do you think are the most important issues for the county and what will you do to address them?

**A:** We must keep Henrico on sound financial footing, maintaining the county's Triple-AAA Bond Rating, because a top financial rating reflects our measured fiscal actions. **Q:** What is the most important issue facing schools in the county and what will you do to address it? **A:** The most important issue in Henrico Schools is equity. I support proactive planning and budgeting that eliminates overcrowded classrooms and schools; recruiting, retaining and rewarding the brightest teachers and staff by empowering them with relevant curriculum and professional development, competitive compensation, increased support and reduced student testing; and equitable allocation of educational resources. All children deserve a first-rate education.

**Q**: How can schools best give students the research tools necessary to understand issues and verify their sources?

**A:** Henrico Schools can best give students the research tools necessary to understand issues and verify their sources by teaching them how to use school and county libraries and responsible internet skills from grades K-12. Students need to understand facts and have opportunities to apply that knowledge when finding solutions. Students also need to be taught how to avoid plagiarism and the written and verbal communication skills needed to accompany their research.

**Q**: What education services do you support for students who are at risk of failing?

**A:** I support quality Early Childhood Development and Response to Intervention (RTI) initiatives. By investing in Pre-K Programs for economically disadvantaged children earlier, they are provided social, developmental and cognitive skills that have proven more effective than trying to close the gap later. For elementary children through secondary, RTI provides remediation, collects data and tracks students on tiered levels based on the support necessary for success.

**Q**: Would you support a high school curriculum that focuses on the civic responsibility of voting?

A: Yes, I support a high school curriculum that focuses on the civic responsibility of voting.

**Q:** What are the best methods of evaluating and supporting teachers?

**A:** The best methods of evaluating and supporting our teachers include formal and informal observations conducted by a qualified administrator. An authentic evaluation process should include pre and post conference expectations. Teachers' strengths and weaknesses should be supported with personal growth plans that include relevant professional development and mentoring opportunities. A growth-minded evaluation process is an asset when recruiting and retaining the best educators.

**Q:** What is the most important issue facing schools in the county and what will you do to address it? **A:** In the Fairfield District the most important issue is the continuation of the same schools not establishing the minimum expectations for what students should know and be able to do at the end of each grade or course in English, mathematics, science, history/social science and other subjects. This has been and on-going issue for several years. I would introduce math, reading and science coaches along with mentors in the schools that fail to meet the states minimum educational requirements.

**Q**: How can schools best give students the research tools necessary to understand issues and verify their sources?

**A:** Continue to provide middle and high school students with Laptops to take home and also provide hotspots for students that do not have Wi-Fi at home. Each school can create a share drive site for students to save their information and it can be reviewed by the staff to verify their sources.

**Q:** What education services do you support for students who are at risk of failing?

**A:** Get parents involved as soon as possible, offer after school mentors and tutors, and offer the child an opportunity to reflect on their needs and structure an educational plan for them to follow. Work with principles and teaching staff on creating interactive mini-lessons and simulations about specific topics such and math and reading.

**Q:** Would you support a high school curriculum that focuses on the civic responsibility of voting? **A:** I would support a civic responsibility for voting in high school as part of their curriculum. I think it is imperative to encourage our students to get involved in the rights and duties of citizenship. It is also equally important to educate our students on the roles of local government and what effects they have on their day to day lives.

**Q:** What are the best methods of evaluating and supporting teachers?

**A:** The best way to evaluate a teacher is to provide a coach to work with the teacher that will provide feedback and instruction when needed. Have the coach observe the teacher over time and include the principle with feedback after several weeks observation. The best way to support a teacher is to ensure that they have all the necessary resources that they need to be successful and ensure that they have adequate professional development and planning time .

**Q:** What is the most important issue facing schools in the county and what will you do to address it? **A:** The national teacher shortage is affecting students and schools every day. We are endeavoring to attract new teachers from all over the country. I have approved funding for frequent job fairs and mentors for our new teachers. New teachers need support and training to adjust to the school environment and the requirements of the job. I have approved increased funding for professional development and teacher pay raises that help our trained teachers stay in Henrico.

**Q**: How can schools best give students the research tools necessary to understand issues and verify their sources?

**A:** Providing current research materials and access to current technology is important to providing students with access to information. We have funded technology tools in our schools for many years. But, students need to be taught to use those tools responsibly. They then can use the skills to research an issue, evaluate slanted material and to find information from multiple sources. Often time internet sources need to be evaluated for accuracy and multiple sources aide in doing just that.

**Q:** What education services do you support for students who are at risk of failing?

**A:** HCPS provides intervention teachers to support students who are below grade level. As a former Intervention teacher, I see the great value in determining the causes of student failure and working with other teachers to create a plan for student success. I support guidance counselors and funding for increasing our counseling staff.

**Q:** Would you support a high school curriculum that focuses on the civic responsibility of voting? **A:** Simply put, yes. I support efforts to teach students civic responsibility, the importance of the freedom that our country affords to its citizens and the importance of each and every vote. I do not advocate for teaching a slanted or particular voting agenda, but a presentation of the issues at hand with opportunities for discussion and learning. Students need to form their own opinions.

**Q:** What are the best methods of evaluating and supporting teachers?

**A:** I have advocated for a supportive and constructive evaluation process for teachers. Teachers should be observed multiple times while teaching in a variety of subject areas. The evaluations should include opportunities for peer evaluations, formal and informal evaluations, videos of the teacher at work, self-evaluation and improvement plans, if needed. New teachers need mentors to guide them as they adjust to the classroom setting.

They need to look at a few things. What is the source? Can the information be verified in multiple places? What is the date of the citation? Students need to learn to evaluate the quality of the URLs and author credits. They are never too young to start learning these life skills.

**Q:** What education services do you support for students who are at risk of failing?

**A:** The key to successful intervention is identifying a student at risk of failing as early as possible. Students benefit from low-stakes assessments and regular feedback. Also, we need to look at the entire picture of a child's life and what might be happening outside of the classroom. Rather than focusing on deficits, we can focus on building upon and broadening their talents and strengths.

**Q:** Would you support a high school curriculum that focuses on the civic responsibility of voting? **A:** If our public school system does not produce fully thriving adults who understand the importance of voting as one of many aspects of civic engagement, we have failed. We have a real opportunity to educate kids on why voting is so important. Their lives (more so now than ever) literally depend on it. **Q:** What are the best methods of evaluating and supporting teachers?

**A:** We have to move away from making decisions about firing, promoting and paying teachers based upon student test scores. We need to develop teacher evaluation systems that include multiple measures of performance including student surveys and classroom observations by experienced peers. Test scores can be a piece of the evaluation but shouldn't be given undue weight.

**Q:** What is the most important issue facing schools in the county and what will you do to address it? **A:** Equity of access: Not all areas of the county have access to the same classroom resources and supports. We need to continue the work the Superintendent has started of drilling down allocation of resources. Not all areas of the county have access to appropriately sized classes. While the secondary average is 22, over 2000 classes last year were over 28 students. We must put a cap on class size to ensure all students in all parts of the county have access to appropriately sized classes.

**Q:** How can schools best give students the research tools necessary to understand issues and verify their sources?

**A:** In a society of retweets and sound bites, we have to teach our students to ask questions that go past surface content. To do that, we must ask them questions that go beyond regurgitation. In Henrico, every student grades 2-12 has a laptop. They have access to an infinite number of resources. When we ask deeper questions of our students that require them to synthesize those resources together, an inherently piece should be to require them to analyze the context and validity of their information.

**Q:** What education services do you support for students who are at risk of failing?

**A:** As I teacher, I know first hand that the best way to ensure success for all our students is to be proactive identifying/providing supports for our students before they are at risk of failing. Often remediation removes students from class and can cause them to fall further behind. Flex time during the school day provides opportunity for students to receive extra support without missing instruction (examples: RTI block in elementary, advisory block in middle, and common lunch in high schools)

**Q:** Would you support a high school curriculum that focuses on the civic responsibility of voting? **A:** Programs of Project Citizen and We the People promote deep understanding of local law and the Constitution. I promote the expansion of these programs throughout Henrico County and with students at all levels. These initiatives require students to move past simple content knowledge and synthesize pieces together to identify problems, articulate defenses, and find solutions.

**Q:** What are the best methods of evaluating and supporting teachers?

**A:** Teacher evaluations need to be based on what is happening in the everyday classroom. This is achieved through genuine and regular observations, not through discrete checklists. To support teachers we must ensure they have appropriate class sizes, the resources they need, and daily unencumbered planning time. We must use a classroom lens to create policy that treats teachers like professionals and doesn't pile more "stuff" on their already overflowing plate.

**Q:** What is the most important issue facing schools in the county and what will you do to address it? **A:** HCPS have made great strides in formulating a strategic plan to decrease inequities/disparities in achievement. Far too many non-fully accredited schools still exist in the Varina and Fairfield districts. Far too many schools have low reading scores and low academic achievement in a county with a 90% rate of schools passing. I will advocate for allocations to create dedicated programs to improve student learning for these areas of low achievement to increase the literacy rate in K-12 grades

**Q**: How can schools best give students the research tools necessary to understand issues and verify their sources?

**A:** Use a learning model which would follow the steps and what is required of the research process. As a part of the education classes offered, librarians and media resource teachers could teach students methods of research, such as how to retrieve data, organize their findings, literature reviews and citation formats. Center lessons around a greater familiarization beyond Google search, with advanced google strategies, journals, meta-analysis studies and use of project based learning assignments.

**Q:** What education services do you support for students who are at risk of failing?

**A:** Dedicated programs and resources for diverse learning needs with educational services are needed, such as supplemental instruction with tutoring supports to enhance learning. Successful interventions to ensure counseling for students who face problems preventing them from doing well in school (emotional problems, absent parents or substance issues). Evaluation of students to determine if more students could benefit (be identified) for an individualized education plan and the available services.

**A:** I plan to continue and build on the foundation of programs developed by the Sheriff of Henrico County over the past 20 years and make their results available to the public. I will make improvements to benefit the Citizens of Henrico, the employees of the Henrico County Sheriff's Office and the inmates entrusted to its care. Specifically, I want to examine the effectiveness of the ORBIT program and explore if Henrico Jails could benefit from the HARP program used by Chesterfield Jail since 2016.

Q: What is the most important role of the Soil and Water Conservation District?

**A:** Districts serve an important role that bridges education and voluntary participation to improve the environment specifically towards homeowners and farms. Districts were formed from the aftermath of the Dust Bowl to help farmers use smarter practices to reduce erosion and pollution. Unlike other
