Questions:

Q: *What do you believe is the top priority for your district and what is your plan to address it?*

A: The state government taxes and spends too much. In 2019, the legislature passed budget House Bill 1700, almost unanimously. It increases the 2018-2020 operating budget to \$121 billion. That's a 15% increase over the 2016-2018 budget. We should cut taxes and spending by 10% across the board. A \$12.1 billion budget cut divided by a population of 8.518 million people would come to \$1,420 per capita savings, money that individuals can spend the best way they see fit

Q: *What measures, if any, would you support to ensure the right to vote and election integrity?*

A: I support measures that make it easy and convenient to register and vote. Sometimes people have expressed fears that non-citizens are voting illegally, but I think cases of illegal voting are rare and we don't need a lot more government spending to fight a non-existent problem. I support ending the war on drugs which will reduce the number of felons and support allowing felons to vote. I've heard it said that people on average commit three felonies per day. Most just don't get caught.

Q: *Regarding fair redistricting (1) Do you support the proposal for a Virginia Redistricting Commission and why? (2) If the constitutional amendment is adopted, what legislation would you support to implement the commission?*

A: I oppose the gerrymandering that's gone on for centuries and would support fair redistricting. We've heard about fair proposals for redistricting for years and it doesn't seem to ever happen in Virginia or most other states. The root problem is that government has too much power to force people to do things they don't want to do so people use gerrymandering and lobbying to get their way. The cure is to reduce the scope and power of government so that winning elections is less important.

Q: *Do you support the Equal Rights Amendment? If yes, what are you willing to do to ensure ratification by the Virginia General Assembly?*

A: I support equal rights under the law for women, minorities, the LGBTQ community and everyone. I support ratification of the Equal Rights Amendment and am glad most of its intended goals are already in effect. I'm wary of additional laws the U.S. Congress and Assembly might pass to further implement it and will carefully consider all legislation to ensure the rights of all people are protected. For example, I would not want private women's colleges to be forced to go coed.

Q: *That solutions would you support to curb gun violence in Virginia?*

A: I support the right to own guns for self-defense and to allow citizens to prevent abuse by a tyrannical government as is happening to the unarmed citizens in Venezuela and Hong Kong. I supported SB 1024 which would have allowed churches to decide whether to allow guns inside. Legalizing marijuana and tax cuts to spur better job opportunities will reduce gun violence. I'm against more restrictive gun laws.

Q: *In a recent public opinion poll, 82% of Virginians believe that people should be able to afford to live in the community where they work. What programs or policies would you support to promote workforce housing in Virginia?*

A: Most high housing costs are caused by government zoning restrictions that prohibit increases in the supply of houses and apartments in existing neighborhoods. Lots of fine good people fight new housing developments and they need to be reminded that NIMBY policies hurt the poor the most, but also the middle class. Obviously, property tax cuts would help lower the cost of housing for everyone. I'm opposed to affordable housing schemes that involve more taxes and bureaucracy; they don't help.

Questions:

Q: *What do you believe is the top priority for your district and what is your plan to address it?*

A: As I speak with voters across the district, the consistent message that I hear is that we must make quality public education a priority. As an educator with nearly 30 years of experience in higher education, I understand this concern. I plan to address this priority by ensuring that we effectively fund our public schools, compensate our teachers with the salaries that they deserve, and support Virginia's institutions of higher education so that rising tuition costs do not impede opportunity.

Q: *What measures, if any, would you support to ensure the right to vote and election integrity?*

A: Ensuring the essential right to vote requires that we be vigilant against all efforts to suppress voting rights. These efforts include restoration of voting rights for individuals released from prison, accessible polling stations, absentee and early voting, automatic voter registration, and increased voter education. Election integrity and voter confidence in that integrity is absolutely essential. I support measures that restrict corporate spending in elections and that require transparency.

Q: *Regarding fair redistricting (1) Do you support the proposal for a Virginia Redistricting Commission and why? (2) If the constitutional amendment is adopted, what legislation would you support to implement the commission?*

A: I support the proposal for a Virginia Redistricting Commission. The ugly history of gerrymandering in Virginia and across the country has disenfranchised minority communities and has allowed systemic, unjust representation to continue, decade after decade. I support legislation that establishes a non-partisan commission to evaluate and determine the boundaries of districts in an impartial and equitable manner.

Q: *Do you support the Equal Rights Amendment? If yes, what are you willing to do to ensure ratification by the Virginia General Assembly?*

A: I am a firm believer in the Equal Rights Amendment, and I pledge to do all I can in Richmond to enact this necessary measure. I will co-sponsor the bill, speak on its behalf, and collaborate with advocacy groups to convince other legislators to support the bill's passing.

Q: *That solutions would you support to curb gun violence in Virginia?*

A: I support effective, common sense gun safety legislation: universal background checks, a ban on assault rifles and high capacity magazines, red flag laws, and closing the gun show loophole. Our state has been affected greatly by gun violence, and we have to increase the safety of our citizens through common sense gun legislation.

Q: *In a recent public opinion poll, 82% of Virginians believe that people should be able to afford to live in the community where they work. What programs or policies would you support to promote workforce housing in Virginia?*

A: Quality, affordable housing that allows people to live within the communities in which they work is essential. I support policies that provide affordable mortgage options, that support mixed-income housing developments, and that provide incentives for individuals to live closer to work and reduce commute travel.

Questions:

Q: *What do you believe is the top priority for your district and what is your plan to address it?*

A: Healthcare. Even though we recently expanded Medicaid which has helped over 300,000 Virginians get access to healthcare, many for the first time in their lives, we still have a crisis in our healthcare system. We have middle class families paying over \$2,000 a month for premiums. We have people still avoiding the emergency room for fear of financial ruin. We continue to have hard-working Virginians who can not afford basic life-saving prescriptions. We must do more to help Virginian families.

Q: *What measures, if any, would you support to ensure the right to vote and election integrity?*

A: As a data systems director for a non-profit I know important it is to ensure the integrity of our voting systems, voter registration information and other data. I will fight to ensure we protect these system. I also believe we must ensure that everyone who is eligible has the opportunity to exercise their right. Therefore, I support no excuse early voting and automatic voter registration.

Q: *Regarding fair redistricting (1) Do you support the proposal for a Virginia Redistricting Commission and why? (2) If the constitutional amendment is adopted, what legislation would you support to implement the commission?*

A: I am proud to have the endorsement of the National Democratic Redistricting Committee due to my strong support for non-partisan redistricting here in Virginia.

Q: *What do you believe is the top priority for your district and what is your plan to address it?*

A: The top priorities for the citizens of the 16th Senate District all deal with local issues, including aging schools, streets in need of paving, stormwater runoff, crumbling sidewalks and sky-high water bills. With regard to schools, I am going to encourage my Senate colleagues to join in and support Senator Bill Stanley's \$3 billion-dollar statewide referendum to improve and modernize all of our aging school stock in the Commonwealth.

Q: *What measures, if any, would you support to ensure the right to vote and election integrity?*

A: In the current election cycle, Virginia has witnessed "mischief" during some Democratic and Republican Primaries. Both political parties – as well as their respective candidates – have endeavored to “game” the system to their advantage. I will introduce a Bill that will require all incumbents and challengers to run in District wide Primaries. There will be no more firehouse caucuses or Saturday morning conventions where voters are disenfranchised because they are unable to participate.

Q: *Regarding fair redistricting (1) Do you support the proposal for a Virginia Redistricting Commission and why? (2) If the constitutional amendment is adopted, what legislation would you support to implement the commission?*

A: i. Yes, I whole heartedly support legislation adopted in 2019 that supports a Constitutional Amendment to establish a 16-member Redistricting Commission. I will support this legislation when it comes up again in 2020. ii. I will introduce legislation that will make it a Class 1 misdemeanor for an incumbent legislator to contact any Redistricting Commissioner in order to influence the manner in which they draw or otherwise reshape a district.

Q: *Do you support the Equal Rights Amendment? If yes, what are you willing to do to ensure ratification by the Virginia General Assembly?*

A: I will vote to support adoption of the Federal Equal Rights Amendment. Some say it is only symbolic. It may be – but it is important to take this pro ERA stand.

Q: *What solutions would you support to curb gun violence in Virginia?*

A: I am in favor of common-sense gun control measures including universal background checks, adoption of Red Flag Laws, and elimination of the Gun Show loophole. I favor the prohibition of all assault rifles including the AR-15 and AK-47 – these are weapons of war.

A: I have been, for over a decade, a strong promoter of workforce housing. There are some areas of my district including South Richmond, Hopewell, and Petersburg where there is a dire need for workforce housing. I have personally toured workforce housing projects which have beautiful facilities including workout gyms, swimming pools, granite tops, hardwood floors, modern plumbing and electricity, etc. Workforce housing does exactly what its name applies – it provides superb living accommodations

Questions:

Q: *What do you believe is the top priority for your district, and what is your plan to address it?*

A: Ensuring that everyone in Chesterfield County has access to healthcare services is my top priority. As a Delegate, I will fight tirelessly to ensure that every Virginian has access to the healthcare they need, regardless of how much money is in their pocket. Q: *What do you believe is the top priority for your district, and what is your plan to address it?*

A: Criminal Justice Reform. We need to eliminate mandatory minimum sentencing for non violent crimes to reduce prison crowding. Questions:

Q: *What do you believe is the top priority for your district, and what is your plan to address it?*

Questions:

Q: *What do you believe is the top priority for your district, and what is your plan to address it?*

A: Education is the top priority for my district. Henrico has been expanding rapidly, as have its student populations, and the decline in state funding per pupil - 10% in real terms since 2008 - makes dealing with that expansion a heavier burden on the locality. The best way to deal with the issue is to prioritize long-term funding increases that aid localities who need it - not tightly focused one-time fixes like the teacher pay increase or tuition freeze only.

Q: *What measures, if any, would you support to ensure the right to vote and election integrity?*

A: First, Virginia must expand legislative restoration of rights to felons and not rely merely on the governor. Second, we must make voting easier by instituting no-excuse absentee voting - the process of absentee approval is overly complex and has little purpose, and often disenfranchises the very young (college students) and the very old. We must also expand voter registration, helping 18 year olds register in their high schools. In the longer term, more ambitious proposals, expansion of vote by

The most important part of the implementing legislation will be to ban the use of political data beyond the demographics required to satisfy the Voting Rights Act in the process. Keeping that d

Q: *Do you support the Equal Rights Amendment? If yes, what are you willing to do to ensure ratification by the Virginia General Assembly?*

A: I absolutely think Virginia should ratify the Equal Rights Amendment. It will have my vote for ratification on the floor or in committee, and I consistently am an advocate for its adoption in caucus. My feelings on this issue are strong, rooted in the year I spent writing a Master's thesis in history on Virginia's first fight for ratification in the 1970s.

Q: *What solutions would you support to curb gun violence in Virginia?*

A: I support several tiers of solutions, some of which are immediately possible and others which would require more extensive legislative and administrative implementation. First, we must immediately reinstate the one-handgun-a-month law. Second, we must implement stronger safe-storage and child-access laws. Third, we must create a red flag program, especially given the number of veteran suicides by gun this would prevent in a state like Virginia with a large number of veterans. In the longer term

By focusing on a better-run state housing office, transit infrastructure, and regional planning we can improve housing affordability and access for Virgi

Q: *What do you believe is the top priority for your district, and what is your plan to address it?*
