WHAT'S COMING UP

Voter Services

Our focus is on how to proceed with registering people to vote, which is at our core, when we no longer feel comfortable sitting at a registration table and when there are very few events that call on us to do so.

We have designed two-sided **sandwich boards** that display basic Vote 411 and registration information, including a QR code that will connect someone directly to the Registrar's office via their own phone. They also feature a display box that can self-distribute Vote 411 Bookmarks and other printed material. These sandwich boards can be left at a safe site or monitored by a Voter Services member at an outdoor venue without need of personal interaction.

We have also developed <u>Voter Fact Sheets</u>, which distill up-to-date information on voting rules in the Metro area. Three versions target the general audience, as well as student and first-time voters, and public housing residents, and have been produced in English and in Spanish. The Fact Sheets can be



distributed electronically, or in printed version, and are meant to be sent as widely as possible. Efforts to coordinate the distribution have been another task for Voter Services. The fact sheets are the inspired result of a true team effort by Nancy Conkright, Donna Granski, Morgan Johns, Dale Johnson-Raney, Rebecca Neale, Alice Tousignant, and Mary Weiser.

Voter Services is also working to sponsor **two billboards** in target areas of the city which will promote Vote 411.org. As we get past the registration period, we will be focusing our energy on ways to get out the vote for the November election.

As we get closer to the election, we are working with local libraries and several civic groups to make **presentations** about voter registration and getting out the vote. We are also planning a **car-caravan** parade to promote registration and voting, to be held early October.

We will continue to look for innovative and safe ways to do what we do—promote well-informed voting.

For the ninth year, the Richmond Metro League is participating in VOTE411, an electronic voter guide for the November election. Our local League is responsible for surveying candidates for Congressional Districts 4 and 7 and Richmond City's races for Mayor, City Council, and School Board. The Virginia

League is handling the US Senate race and the two Virginia Constitutional Amendments, and the US League is handling the presidential race.

Our goal is to have the information live on the website www.VOTE411.org by September 19, when early voting begins. In addition to the voter guide information on candidates and ballot issues, VOTE411 has general information on registering and voting in all states.



Redistricting

Redistricting is on the Ballot!

There is a history of gerrymandering in Virginia by both parties. Every ten years when the General Assembly revised election districts, whichever party was in the majority drew the districts to garner more seats for that party.

On November 3rd, Virginia voters will decide whether to approve a state Constitutional Amendment that creates a Commission to draw election districts. The Commission comprises citizens and legislators and will be led by a citizen. The Commission will hold public hearings, and its communications will be treated as public documents.



The vote on this Amendment is the culmination of several years' work by groups and individuals seeking to establish a Redistricting Commission. In 2020, the General Assembly passed the Amendment in the second of two consecutive sessions, as required by the Virginia Constitution. In November, it will be on the ballot for final approval by voters.

The League of Women Voters of Virginia supports the Amendment, and some of us in the Richmond Metro League are participating in a postcard and yard sign campaign that includes thousands of postcards mailed by local leagues throughout the state.

Many, however, oppose passage of the Redistricting Amendment. A recent lawsuit objects to the role of the state Supreme Court in drawing districts if the Commission fails to do so.

Diversity, Equity, and Inclusion

In December 2019, LWV-US formally published its DEI Policy, stating that "Diversity, equity, and inclusion are central to the organization's current and future success in engaging all individuals, households, communities, and policy makers in creating a more perfect democracy". State Leagues are now forming issue groups to determine how to realize the goals of this policy. LWV-RMA's Doris Bey has convened the Virginia issue group, which is meeting monthly to consider ways to embed DEI into the state League's program and to provide guidance to local leagues.



In these unusual times of global pandemic, racial injustice, economic disparity, and housing challenges, focusing on DEI principles gives us a chance to grow and become actively engaged. Change is happening all around us. James Baldwin says, "have a plan." We're excited about developing that plan!

Our local Diversity, Equity and Inclusion Committee, formed in July, is exploring ways to educate members on what these terms mean and how we can use a DEI lens to examine our League's activities and governance. The committee is

gathering suggestions for speakers who could kick off a virtual discussion of DEI.

Zoom virtual events

Setting the Table

As we all know, by mid-March COVID-19 had made in-person League meetings impossible. Nonetheless, under the auspices of Membership and Engagement chair Jeanne D'Ascoli, in the first week in May, RMA rolled out a plan. The "**Setting the Table**" series aimed to help our members think about the work that would need to be done in the upcoming months, even when we didn't know the conditions under which we would be operating. In May, Zoom sessions on the Census, VOTE411, voter registration during a pandemic, RMA's new and newly-virtual high school civics education program, and the history and future of the fight for the ERA, our members looked both to the past and forward. The enthusiastic response to the series showed our members' ability to rise to a dramatically changed world and plan for an uncertain future. *Nicely done Leaguers*!

Affordable Housing Study



The LWV-VA Affordable Housing Study was initiated by the LWV-Richmond Metropolitan Area, led by Alice Tousignant, in response to revelations that the City of Richmond as well as other Virginia cities, both large and mid-size, have among the highest eviction rates in the nation. A state-wide study of affordable housing was approved at the LWV-VA Convention in June 2019, with consensus questions going to local Leagues over the summer months. As we all know, safe, affordable housing

is a health issue, an economic issue, and an environmental issue, as well as a moral and equity issue.

RMA members attending the virtual July consensus meeting on Zoom approved five of the study questions and gave partial approval to the sixth. There was no consensus among attending members on the question of whether state laws should mitigate the impact of evictions by expunging eviction records. Members expressed some support for such legislation but offered comments on the phrasing and details of the study question.

Election Laws Study

Over three virtual meetings in July and August 2020, RMA members heard reports from the LWV-VA Election Position Study Committee on updating the LWV-VA 2011 Election Laws position. This Study, initiated through the leadership of RMA members Jane Newell and Becki Lawson, encompasses two phases. The first phase addressed questions concerning these topics:

- Whether the Virginia Department of Elections is doing enough to make the election system secure.
- In light of new legislation passed by the General Assembly, whether the LWV-VA should state positions on no-excuse absentee voting or the photo ID.
- Whether general registrars should be trained and funded to conduct risk-limiting audits before an election is certified.

After reviewing information on each of these questions, RMA members voiced support for the report as written. They commended the Study Committee for the depth, detail, and thoroughness of their treatment of these important topics. The second phase of the position study has been launched, with completion expected in 2021.

Equal Rights Amendment

Forty-eight years after Congress passed the Equal Rights Amendment to the Constitution, Virginia became the 38th state to ratify the amendment. It was a momentous occasion in the General Assembly, full of cheers and tears of joy. However, because Congress had set a time limit for full ratification, the Department of Justice instructed the National Archivist not to publish the amendment to the Constitution. Soon after Virginia's ratification, the U.S. House of Representatives voted to eliminate the deadline for ratification. This legislation has not been taken up by the U.S. Senate.



Three exciting pieces of news from DC:

- The Attorneys General of Nevada, Illinois, and Virginia, the last three states to ratify the ERA, filed a lawsuit to declare the deadline not binding, and to instruct the National Archivist to certify the amendment.
- Equal Means Equal (EME), one of our League's ERA partner organizations, filed suit to require the Archivist to certify ratification and to dismiss anti-ERA suits from states that had defeated or rescinded ratification.
- Amicus briefs to the EME suit have been filed by 69 organizations, the United States Conference of Mayors, and 93 large corporations.

From the bottom of my heart, thank you all for being there these past three years as we all helped make it happen!

Virtual Voter Registration Training

The Voter Services Committee has had an interesting year to date, coping with the Covid-19 shutdown in the midst of an important election year. We moved our annual **Voter Registration Training** from an inperson event in July to a virtual training led by Taylor Melton from the Department of Elections on August 15th. Nonetheless, we still hosted about 50 people for the certified training.

Votes for Women: 100 Years!

August 26, 2020 marked the centennial of the certification of the 19th amendment, granting women the right to vote. The LWV-RMA Centennial Committee, co-chaired by Lynn Johnston and Mary Crutchfield, partnered with the Virginia Museum of History and Culture (VMHC) to commemorate this historic event. The public gathering, held outdoors on the front steps of VMHC, allowed everyone to attend in a safe environment, with chairs appropriately distanced on the broad entry walk. Speakers included VMHC President, and CEO, Jamie Bosket; Governor Ralph Northam; Richmond Mayor Levar Stoney; and Dr. Sandra Treadway, Librarian of Virginia.

LWV-RMA members also participated, with Pat Fishback acting as Mistress of Ceremonies. Mary Crutchfield spoke about the history of the founding of the League of Women Voters in Virginia. Lynn Johnston and Morgan Johns shared the podium, presenting past and future challenges to our LWV mission of voter education, advocacy, access and citizen participation. Doris Bey, LWV-RMA board member and LWV-VA DEI Chair, spoke about the

history and activism of women of color and shared the Maggie Lena Walker story. Doris contributed further by bringing members of the Alumni Chapter of Delta Sigma Theta Sorority, who volunteered as hostesses. Doris also invited a wonderful vocalist, the Rev. Carla Jackson. Nancy Lowden, in authentic Suffragist costume, told the story of the final steps required to ratify the 19th Amendment

All attendees received a FAQ Sheet for Voters, a VOTE411 bookmark, and a detailed list of sites and map for a driving tour of Richmond's women's suffrage history locations and museum exhibits.

Electoral Board Observation Teams

The Election Modernization Committee now has Electoral Board Observation Teams in Richmond, Henrico, Chesterfield and Hanover. Observers note that these local boards have common issues in 2020:

- poll location changes due to inability to use retirement communities;
- concerns about the volume of mail-in voting;
- need for new election officers:
- establishing satellite voting centers for early voting;
- timeline challenges with delayed candidate submissions; and
- last minute legislation such as requirements for drop-boxes.

Relocation of the Richmond Registrar's Office to 2134 West Laburnum Avenue, Richmond 23227, is complete. Voting will start at this new location on September 18. The <u>committee's notes are available online</u>.

LWV-Ohio leader Treva Cromwell inspires a new generation

New member Hope Norman writes: "In 2002 when I moved to Charlottesville, my entrepreneurship professor and mentor reached out to me to ask that I help him find someone to take his 90-year-old mother shopping. She and her husband lived in a retirement community and could no longer drive. I told my professor that, of course, I'd take her shopping - no need to find another driver.

"Treva Cromwell was enchanting. She was gracious, sharp, humble, and exuded contentedness. I learned that she had been the president of the League of Women Voters of Ohio before she moved to Virginia. Further, once she moved to our state, she led an extensive and successful campaign to preserve watersheds in Virginia. I determined that I wanted to be like her! I wanted to make meaningful contributions, and I wanted to enter old age with her grace. I decided that if ever I had a daughter, I would name her Treva. *Treva Cromwell* died in 2004, and *Treva Norman* was born in 2006."

In Memoriam: Mattie Roane



Long-time loyal member of the Richmond Metro League, Mattie Roane, died on August 18. Her obituary gives us a sense of this strong woman: "Mattie Frances Roane was born in Historic Jackson Ward in Richmond, Va. She was the first Miss Walker at Maggie Walker High School here in Richmond. She earned her Bachelor's degree in 2.5 years at Virginia Union University. When the University of Virginia would not allow her to attend their graduate school because of her race, the state of Virginia paid for her to attend Columbia University in New York, where she earned a Master's degree in psychology. In her 30 years with Richmond Public Schools, she taught at Nathaniel Bacon Elementary, Bowler Elementary and A.V. Norrell Elementary Schools, and served as a Curriculum Specialist. She was active in the community as a

member of First African Baptist Church, as a Girl Scout leader and as a very involved member of the League of Women Voters. She also owned her own dressmaking shop." The family notes that memorials may be made to the League of Women Voters.
