Private group tour of the museum library Entry to the exhibit *Julia Child: A Recipe for Life*

Taking advantage of our meeting location at the Virginia Museum of History & Culture, attendees will have the opportunity to tour the museum's research library. Included in the tour is special access to the library's manuscript vault, which contains some of the museum's most important collections, and an up-close examination of original manuscripts, including items related to the Equal Suffrage League of Virginia, the LWV's historical predecessor. After the meeting concludes, attendees are invited to tour the rest of the museum's exhibits, including the newly opened Julia Child: A Recipe for Life. Those attendees that are VMHC members have complimentary admission. Those that are not members will have the ability to purchase a ticket for the special reduced rate of \$5.

A Message from the Co-Presidents

This note highlights some of the League's accomplishments this year, as well as the measures to be voted on at our annual meeting on May 4th.

Our Voter Service activities began with a September all-member "Refresh" meeting, where members volunteered for registration events, candidates' meetings, VOTE411, Voter Fact Sheets, and Call 12. We continued and expanded our high school Civics Education Program and established a relationship with VCU's VCU Votes class. We expect these programs to grow in the future and funding is included in the proposed budget.

Advocacy areas of interest included public education, affordable housing, transportation, and campaign finance. At the General Assembly members participated in the weekly Women's Legislative Round Table meetings and in League Day in February. Our allmember advocacy planning meeting in January developed the 2024-2025 program to be adopted at the annual meeting.

Our members also attended local electoral board and school board meetings, started locality-based unit meetings, had an outing on the PULSE bus to the Library of Virginia, and held an online discussion of *The Sum of Us: What Racism Costs Everyone and How We Can Prosper Together*.

The national LWV is engaged in a multi-year reorganization process called Transformation, which will result in changes for local and state Leagues. To prepare, new bylaws to become effective as required will be presented at the annual meeting. Also, a new fund-raising effort is included in the proposed budget.

We hope to see you at the annual meeting where we will vote on these measures and on a slate of officers and directors. We also will be able to socialize in person (not ZOOM!) and enjoy a special presentation by staff of the Museum of History and Culture.

Proposed Changes to Advocacy Positions

A *position* is a statement of principles regarding an issue that allows the League to advocate on that issue. A position is adopted after careful study and consensus by League members. Each year we review our local positions, and in alternating years we review the national and state positions. After each review, we may propose changes that may require new studies prior to formal adoption.

Review of *Impact on Issues*. At the Advocacy Program Planning meeting in January 2024, members reviewed the national League's positions for 2022-2024. No changes or new studies were recommended at this level. Three proposals by other Leagues to amend the national positions were considered:

A video by the Washington state LWV explained a study they conducted on the <u>decline of</u> <u>local news</u>. Attendees voted to concur with LWVWA **Local News** position as written.

The LWVUS **Climate Change** Interest Group has requested to add Climate Change as a top-level LWVUS focus area. After discussion, members voted to support recognizing the importance of Climate Change as essential to Making Democracy Work (the current top-level focus); however, we would not like to see this topic elevated in a way that is detrimental to current priorities.

Members also discussed the request by LWV Vermont to update the LWVUS position on **Healthcare** based on their state study. We were not able to reach consensus and so we did not concur with the LWVVT position.

Review of LWVRMA Positions. Members expressed interest in starting a local study on encouraging the Local Board of Elections to hire Election Officers for part-time positions on election day, rather than requiring workers to be on duty for as long as 16 hours. **A motion to begin a study on part-time positions for local election workers was approved**.

Proposed Advocacy Plan

At the January meeting, we began by reviewing the activities that our League carried out this year in advocating for our priorities.

Alice Tousignant then led attendees in a brainstorming exercise to identify goals for the coming year, to associate them with specific actions, and to categorize them according to the committee or group that should consider them for implementation.

Proposed Change to Bylaws

LWVUS has embarked on an initiative called *Framing the Future Membership Transformation*. Because the new membership model will involve differences in how dues are determined, collected, and shared among the national, state, and local Leagues, some sections of our bylaws must be changed to make them consistent with the new processes.

- Article VI Section 3, *Quorum*, clarifies that membership status is determined by a person's listing in the official roster.
- Article IX Section 2, *Finance Committee*, eliminates reference to per-member payments to the national and state Leagues.
- Article X Section 2, *Dues*, is replaced by language aligned with the new membership model, including tying the term of membership to one's joining or renewal date rather than to a fiscal year.

The proposed changes will take place after the new LWVUS computer system has been deployed to all Leagues in 2025. We will have a presentation on the membership changes at the Annual Meeting.

Proposed Budget, FY 2024-2025

At the Annual Meeting, we will vote to approve the proposed budget, which is available at this link: <u>https://bit.ly/BudgetFY25</u>

Our **income** is from three sources: membership dues, fundraising, and the LWVRMA Education Fund. This year, our local League retains about 36% of member dues; the remainder is passed along to the Virginia and US Leagues (called "Per Member Payment," or "PMP"). FY 2026 will mark the beginning of a new member model, resulting in our local League retaining a smaller percentage of member dues.

Our **expenses** include operating costs around Membership, Administration, and Program. Included are member engagement, Zoom, website, insurance, registration for delegates to League Convention and Council, program planning, voter service, and member events, among others.

In keeping with our goal to engage younger voters and influence first-time voters to become life-long voters, the FY25 budget contains funding for student interns as well as funding for student Voter Service activities at the high school and university levels. Funds for billboards were not included in the FY25 budget to allow focus on engagement of young and first-time voters.

The Education Fund can be used for education-related expenses like voter service materials and activities, public programs, and part of our PMP. The General Fund can be used for other League expenses. After FY25, our local League will receive a smaller portion of member dues as a result of LWVUS's *Framing the Future Membership Transformation* initiative. In recognition that it takes money to better achieve our local Program goals, the Finance Committee recommends conducting a fundraising campaign in 2024 to increase funds in both the Ed Fund and the LWVRMA General Fund. The target for the campaign is \$8,000. Moving forward, the Finance Committee intends to build a LWVRMA culture of annual giving and legacy giving among its members to enable our future work.
